### *From the Desk of Nancy Church, RN*

When I started at the Berrien County Cancer Service, I had several years of nursing experience which included some patients with cancer but I had not worked with those with cancer as a group and I had never made a home visit as a nurse. I fell in love with the job my first day as I drove around with the director and was able to meet the most amazing people. Meeting people in their homes was so different from the hospital environment that I was used to. The relationships formed felt more like family than patients. This month has been declared “Community Health Worker Appreciation Month” by Governor Whitmer. In celebration of that appreciation, I have a special story about a special young man who has recently shown BCCS how grateful he is for the care he received from us.

### **Kevin Jones – An Enthusiastic Supporter and Survivor!**

In 2014, a concerned Dad stopped by the BCCS office to find out what services we provided. His 15-year-old son, Kevin, had recently been diagnosed with brain cancer and would be coming back from the University of Chicago in about a week. Soon our nurse, Connie, became acquainted with Kevin and was there to answer questions, give guidance, and assess his progress. Connie was able to help Kevin by drawing his lab work at home as well as at school, so he was able to keep up with his schoolwork more easily. About 6 months later, Kevin completed his treatment and has been cancer free ever since.

For many people, the story might end there, but Kevin is an unusual young man. Every year since then, Kevin has found ways to give back to those who assisted him along the journey. This year, Kevin collected an amazing 2,200 pop cans and \$1,000 in donations! He divided the funds between the 3 outstanding programs/nonprofits that supported him when he needed it most: Berrien County Cancer Service, Ronald McDonald House at Comer’s Children Hospital, and the University of Chicago Comer’s Child Life Program, who received 201 toys for children. Last year he created a survivor video and documentary of his story to promote brain cancer awareness and to give hope to those who are also going through cancer treatment. Through radio and social media, he encouraged the community to donate to support those who had helped him along the way. This documentary called “A Change of Mind” and a short video, “Project Survivor” can be found on Kevin’s Facebook site: KJones Production LLC in the video section as well as on our Facebook page. Kevin has this to say, “Thank you to all of the Berrien County residents for making My Dream come true to help give back to the great people of Berrien County Cancer Service”.
